

Work starts on Wallasey gas holders

? National Grid is dismantling and removing two of three gasholders at its Dock Road site in Wallasey. ? This is part of a national programme to regenerate gasholder sites for future use.

National Grid has started work to remove gasholders in Wallasey as part of a nationwide programme to clear redundant industrial sites for future use.

The first stage will involve taking down one of the three gasholders, which the company expects to be removed by March 2015. Further work will take place on the second gasholder, which is expected to be removed by July 2015. A further announcement is likely to be this year on when the remaining gasholder will be removed.

The site and surrounding area has a rich history in securing Wallasey's gas supply. The gasholder site was established in 1858 by the Wallasey Local Board of Health and served New Brighton, Poulton, Seacombe and Egremont. A railway was built in 1901 to help support the works, which were expanded once again in 1918 to meet rising demand.

Today, gasholders are no longer needed due to investments in the national network, meaning that gas can be stored in the pipe system or underground.

Land Regeneration Manager, Matthew Pearce, said: "It has been several years since the gasholders were last used and our work is the next step in cleaning up this redundant site. "Although there are no specific plans for the site at the moment, we hope that regeneration will breathe new life into the area at some point in the future.

"Our team will aim to carry out the work as quickly and efficiently as we can and we will be sure to update the surrounding community and neighbours throughout the work."

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
